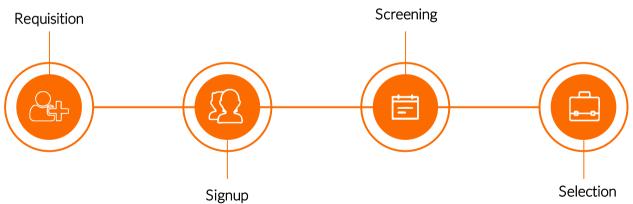

An offshore head supervisor managing & monitoring whole his team working remotely for various managers.

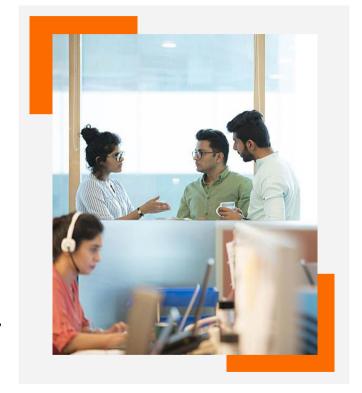
Multiple teams being managed by individual remote supervisors for US for diverse managers.

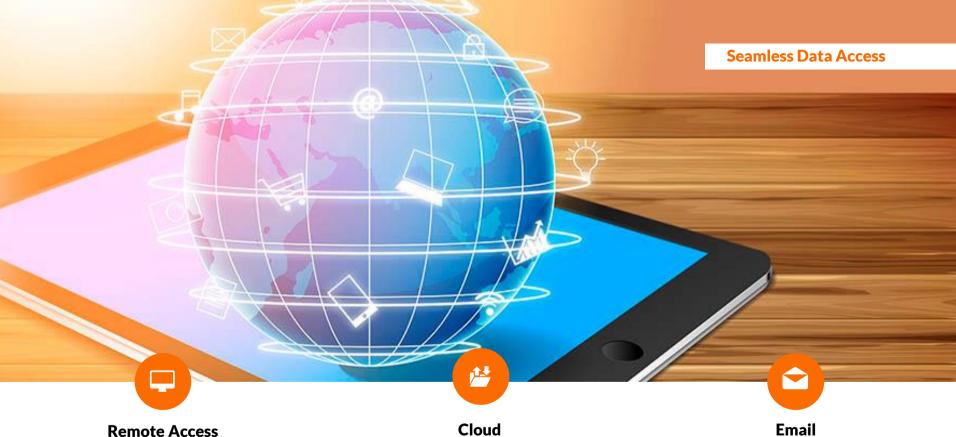
